

1                   STEW PETERS: He is known on Twitter as  
2 @Johnheretohelp for a good reason. He's been forced  
3 to use the name Ryan White in times past, but his  
4 real name, if you didn't know, is Dr. Jonathan  
5 McGreevey.

6                   Now he has been targeted and jailed. He  
7 has been tortured to ends that you could never  
8 imagine, but he simply wants to be introduced as  
9 Dr. Jonathan McGreevey, scientist/soldier/human.  
10 The deep state cabal fears this man.

11                  Now as Dr. McGreevey and I began talking  
12 about a possible interview on this program, I  
13 learned a lot about him. I learned that McGreevey  
14 started crunching numbers for the government very  
15 early on in his career which is when he was first  
16 granted his clearance.

17                  Now that was a long time ago. Computers he  
18 said were not widely available and if they were,  
19 they were not very powerful so they still needed and  
20 relied on people to do the work.

21                  McGreevey's career advanced quickly.  
22 Encryption work led to satellite work, ultimately  
23 work on spy satellites mostly with the National  
24 Reconnaissance Office, the NRO. From there, things

1 would get really wild.

2 McGreevey has served in our military, he  
3 has served in the intelligence community, and he was  
4 responding to a calling. He was in those places for  
5 all of the right reasons, and that does not sit well  
6 with the global cabal.

7 And McGreevey has been given ultimatums.  
8 He's been offered money, lots of money. He and his  
9 family have been threatened with physical harm,  
10 kidnapping and death. He has been physically  
11 tortured to ends that I am not going mention here  
12 and I will let him tell you about if he should feel  
13 so comfortable in doing so.

14 McGreevey illustrated the career path  
15 explaining to me how everything just kind of fell in  
16 line as things became more in depth in school and  
17 then ultimately in grad school. The institutions  
18 that he attended, like Hopkins, have very deep  
19 government and military ties.

20 And as progressing into the Army, he still  
21 maintained his connections to everything from the  
22 past and continued to work on various projects  
23 either as a consultant or in a think tank type  
24 situations as he so described it.

1                   Now McGreevey became extremely close with a  
2 nonviolent Muslim brotherhood believer, and he  
3 became imbedded. He introduced McGreevey to many  
4 people that he was able to pass information to in an  
5 attempt to thwart violence.

6                   The information superhighway quickly opened  
7 up for McGreevey. He soon found himself passing  
8 information to local and federal law enforcement and  
9 ultimately to the DOJ in Baltimore where he began  
10 working with Rod Rosenstein.

11                  He went from a sort of anonymous informant  
12 to an information collector on behalf of the United  
13 States government being tasked with certain things,  
14 working terrorist cases and given the cover of Ryan  
15 White.

16                  They chose the name Ryan because of  
17 McGreevey's Irish heritage and White was chosen,  
18 well, because it's a family name and someone could  
19 actually research his background and corroborate  
20 things rather easily.

21                  McGreevey ultimately started blowing the  
22 whistle on Obama's criminal activity and Rod  
23 Rosenstein's dirty agenda. McGreevey has been a  
24 thorn in the side of the deep state cabal for a very

1 long time. They hate him. They want him dead.

2                   But now here today on this show on this  
3 platform in front of the whole wide world, it is  
4 time to lay it all out on the table. He joins us by  
5 phone, and he'll be here momentarily.

6                   Now in our conversation today, we will be  
7 exposing very specific and certain truths about the  
8 2020 presidential and down ballot election fraud,  
9 the real truth behind the January 6th big lie. He  
10 will name names as never named before, and maybe  
11 most importantly, COVID-19, the vaccines, Anthony  
12 Fauci, Bill Gates, the ultimate plan of these  
13 globalists to take on the west, topple and destroy  
14 an entire political system, overthrow a  
15 constitutional republic and ultimately to gain total  
16 and complete subservience from every global citizen.

17                   Now in our text exchange last evening,  
18 Dr. McGreevey told me, "This will most likely put a  
19 strain on certain family members. I'm going to  
20 reveal information that's not come out previously,  
21 information that I have corroborated, and certain  
22 people who have a connection to Pelosi are going to  
23 know where it came from." Well, they're going to  
24 know because he's going to say it here.

1                   Dr. McGreevey, I cannot tell you how much I  
2 appreciate your bravery, and I can confidently say  
3 that it's my belief that I speak for millions when I  
4 say thank you for being here. Thank you for  
5 agreeing to do this.

6                   So I want to start here. I think it's  
7 important that we establish the credibility of some  
8 transcripts that -- you know, you had some  
9 conversations with defamation attorney Lin Wood. He  
10 has come under scrutiny, of course. People trying  
11 to discredit these transcripts: Oh, Lin Wood is  
12 making it up.

13                  Can you 100 percent without question  
14 validate/corroborate those words as true and correct  
15 conversations, an account of fact that you can back  
16 up?

17                  JONATHAN McGREEVEY: Yes, they're  
18 absolutely accurate. I can back it up. I don't say  
19 anything or put anything out there that I can't back  
20 up, and that was me on there.

21                  Mr. Wood was kind enough to -- we spoke  
22 prior to that, of course, but he was kind enough to  
23 invite me to his home for a few days,  
24 (indiscernible), and then we did the interviews.

1                   STEW PETERS: And during those interviews,  
2 the transcripts accurately reflect what was said?  
3 Those are a true, unquestionable 100 percent correct  
4 account of fact?

5                   JONATHAN McGREEVEY: Yes.

6                   STEW PETERS: Wonderful. Okay. So I have  
7 articulated a little bit of your past. Was there  
8 anything that I left out? Is there anything that  
9 you want to say before we get started here on the  
10 2020 presidential down ballot election fraud? Is  
11 there anything that you want to add that you want  
12 people to know about you, who you are and how we got  
13 to this point?

14                  JONATHAN McGREEVEY: I was never  
15 comfortable talking about myself. Anything I can do  
16 is only because the Lord has blessed me many times  
17 over. But I have not only my background, which  
18 you've gone over some, but my family has similar  
19 backgrounds; the military, things like that going  
20 back decades.

21                  So you're in those circles so it was easy  
22 for me to be discovered, for lack of a better word,  
23 at an earlier age (indiscernible). And you meet the  
24 same people, go to school with them, talk to them

1 and, you know, have family ties or professional ties  
2 to many people who we're going to be talking about.  
3 And they're going to be upset again, but they know  
4 how I am so...

5 STEW PETERS: People are going to be upset  
6 with what it is we're talking about, but there are  
7 going to be hundreds of millions of people  
8 vindicated as a result of this interview.

9 And when I say things like "this interview  
10 is going to change America," what I mean by that is  
11 people don't really know. People don't want to  
12 believe that this horrific atrocity is taking place  
13 in our country. Is this a Marxist coup?

14 JONATHAN McGREEVEY: It's an attempt.  
15 We're not done yet. This wasn't the attack yet.  
16 This is the softening up stage, but yes.

17 STEW PETERS: So we have not seen the  
18 beginning of the horror?

19 JONATHAN McGREEVEY: No.

20 STEW PETERS: Do you project that this is  
21 going to get worse before it gets better?

22 JONATHAN McGREEVEY: Much worse.

23 STEW PETERS: Can you elaborate on that?  
24 What can you realistically say that you believe the

1 American public is going to witness or global  
2 citizens are going to witness before this thing is  
3 all over with?

4 JONATHAN McGREEVEY: Well, let me ask  
5 military or students of history a question. We're  
6 seeing food shortages, ammo shortages, fuel  
7 shortages, electric shortages, medication shortages.  
8 Does this not look like a prelude to an attack? Is  
9 this not to soften up a population?

10 And then you add to that a biological agent  
11 that causes wide-spread damage and the vaccine is  
12 worse -- it's a mega version of it -- and then  
13 you're going to have a percentage of the population  
14 that's fine. They can handle it. Always happens.

15 You're going to have a percentage that's  
16 going to have a massive reaction, drop dead right  
17 now. Same thing. The majority of people it's going  
18 take two to three years to see the actual damage  
19 what it caused, and you're talking about over half  
20 the population of the country at this point.

21 When that happens, they're going to be  
22 debilitated, so they're going to have strength/half  
23 military and the half that's left is going to be  
24 taking care of the other half. What does that do?

1       That makes everyone dependent on the government.

2           Family of four, you're both working, paying  
3       your bills, taking care of everything. What if  
4       those bills are \$100,000 a month because everyone  
5       has severe health problems? How long can you do  
6       that?

7           The goal is dependence on government. They  
8       didn't want wide-spread death. There are biological  
9       agents that will do that. If they want to wipe out  
10      the population drastically, they could. There are  
11      some that will do that. They tried hard to get  
12      them.

13           But this one will shorten -- it will make  
14      you easy to control. The people who didn't take it  
15      or the people who were resistant to it or whatever,  
16      they're going to be taking care of other people.  
17      But your strength overall is going to be drastically  
18      reduced and everyone dependent on the government.

19           STEW PETERS: We know the election was  
20      stolen. Who stole it and how?

21           JONATHAN McGREEVEY: Honestly, the  
22      Democrats stole it. They've been doing this for a  
23      long time. There are Republicans who participated  
24      in this and buy blocks of votes. You just basically

1 send some tax money here, you know, then you control  
2 (indiscernible). Send some tax money there and  
3 you're buying. And they do that: 5,000 votes here,  
4 7,000 votes here, but it adds up and it guarantees  
5 you these blocks.

6 (Indiscernible) guilty of it as well. It's  
7 business as usual. The Democrats have cheated.  
8 They caused fraud going back to Obama. With  
9 Hillary, they guaranteed the win. She couldn't  
10 lose. They had to (indiscernible) process. They  
11 were doing this.

12 People tried to expose it. There were  
13 people like myself, like Dr. McClelley (spelled  
14 phonetically) who exposed it and paid for it. There  
15 are other countries, Russia and Israel, who did not  
16 change anything but just stopped changes from  
17 happening. You know, it's like stopping a computer  
18 virus. They stopped it.

19 And President Trump came on strong and  
20 broke their algorithm so he won. That really,  
21 really upset them because they had everything in  
22 place. This whole COVID mess was supposed to happen  
23 in Hillary's second term.

24 Imagine if we didn't have President Trump

1 in the office and this had occurred; the hysteria  
2 that would be nonstop, the restrictions, because  
3 that's what they wanted. They would use this to  
4 suspend anything and change -- well, they're trying  
5 now. You can see it. Imagine under four years of a  
6 Hillary presidency what it would be.

7 STEW PETERS: So I have said in recent  
8 times past that this was a 16-year plan. Obama was  
9 the first eight. He was marching the football down  
10 to the goal line, for lack of a better analogy. He  
11 was going to hand this thing off to Hillary Clinton.  
12 She was going to punch it into the endzone. That  
13 was it. Full Marxism. The whole thing was done.

14 Trump got in their way. He was a speed  
15 bump for them. The stolen election is not really  
16 the big part of the plan here. It's actually not  
17 the big news. That was just something that they had  
18 to do because they had to get Trump out of the way.  
19 They had to get Trump supporters out of the way.

20 So who was it? If you want to name, who is  
21 the most responsible for this election theft? Who  
22 orchestrated this whole thing? Where did the money  
23 come from?

24 JONATHAN McGREEVEY: The money came from

1 all over the world, companies, Facebook, Gates.  
2 Things like this. They control money all over the  
3 world. It's just a matter of sending it back in.

4 They started up like the old  
5 (indiscernible) Get Out The Vote over a year ago  
6 just to bring this money in legitimately so it's not  
7 a great big dump of cash. But all these  
8 organizations are coming up so that money is  
9 flowing.

10 So much of the COVID money went into the  
11 fraud. You know, President Trump put out stimulus.  
12 People are home, scared. So much of that money went  
13 into stealing the election in multiple states and  
14 into their own pockets.

15 But the money is easy for them to move.  
16 They have so much of it. There's nothing they can't  
17 afford, and they can buy people and promise people  
18 positions.

19 STEW PETERS: So when people want to point  
20 at specific involved parties, people point at Italy.  
21 There's the Italygate. People point at China.  
22 China stole the election.

23 Was this a global concerted effort as  
24 George Papadopoulos recently said on this program?

1 Is it because there were so many people involved  
2 with this that that is what's making it so difficult  
3 to prove it?

4                   JONATHAN McGREEVEY: You can prove it  
5 locally. I mean, you can just throw out the votes  
6 that are duplicated, the ones that were mass  
7 produced, the ones that are not legitimate.

8                   There are certainly other countries  
9 involved. China -- the Communist Party of China,  
10 the government, not the individual people -- they're  
11 certainly involved, and they were running through  
12 other countries like Italy, like Iran as a firewall.  
13 They're using smaller countries as a firewall to  
14 hide their involvement.

15                   They're absolutely involved. They provided  
16 money. They have -- and they've been moving towards  
17 this for a long time. It wasn't just somebody said,  
18 "Oh, hey, we don't like Trump. Get him out."

19 They've been moving towards this for quite a while.

20                   President Trump was never supposed to be in  
21 the way. And when the plans came out then, you  
22 know, it was like President Trump is here. What can  
23 we do? We have to modify things. It's like it will  
24 still work. We just have to modify it.

1                   And now they're in a panic free-fall  
2 because of the (indiscernible) but also because  
3 people are not putting up with the hysteria over  
4 COVID, the next version, anything like this.  
5 They're like we're not wearing masks. Up yours.  
6 I'm not taking the vaccine.

7                   There's too much negative stuff and they're  
8 losing control, so they're modifying their message  
9 saying don't vaccinate anybody under 14. Don't do  
10 it under 30. Just get it to the adults. Get it to  
11 the producers and the taxpayers. Get it to them,  
12 the patriots. Get it to the older adults because we  
13 don't care about them. We want the younger  
14 generation, 30 and under, because we can  
15 indoctrinate them.

16                  We're never going to convince you. You're  
17 a patriot, so go away and die somewhere. We want  
18 the younger ones that we can convince, that we can  
19 sway to ours just like the Critical Race Theory.  
20 They want it in schools because they want your  
21 children to believe what -- they want your children  
22 to feel bad. They want them to question everything  
23 they do and feel bad and eventually they'll turn  
24 that around and resent you.

1           They want your children to be turned  
2 against you and hate you. They can't convince you.  
3 You're set and they know it, so go die somewhere.  
4 We'll get your children. And they're trying. It's  
5 just a form of indoctrination.

6           STEW PETERS: When people say -- when I  
7 told people I was going to have you on the program,  
8 they say, "He has the receipts." What do they mean  
9 by that? What receipts do you have?

10          JONATHAN McGREEVEY: Oh, there's paperwork  
11 I've put up, cases I've been involved with online.  
12 There's -- a lot of cases are sealed or individual  
13 parts of it are sealed to hide exactly where things  
14 came from, but there's -- you can fine the cases  
15 online, the terrorist cases, things like that, that  
16 I've worked through with the same people, Rod and  
17 the FBI and the DOJ all through there; you know,  
18 Lisa Monaco. All of them are all through it so they  
19 can never say, "Oh, I don't know." You're right  
20 there. There's your signature. We worked on the  
21 case together.

22          So it's just -- you know, it's all public  
23 access, although much of it is sealed. But it is  
24 available to check a lot of it, and there are -- a

1 little more are coming out. A lot of it is sealed  
2 just to protect people who are undercover or protect  
3 how they got the information, but more is coming  
4 out.

5 But it's not like oh, I was involved with  
6 DOJ. There are numerous cases. There are people  
7 sitting in prison, you know, put there because of  
8 the undercover work. So there are articles about it  
9 as it was going along about the arrests and about  
10 who was involved, things like that.

11 STEW PETERS: There are people sitting in  
12 prison right now for a so-called insurrection that  
13 took place on the 6th of January. We're going to  
14 get into that right after the break.

15 We are on the phone with Twitter handle  
16 @Johnheretohelp. His name is Dr. Jonathan  
17 McGreevey.

18 (Break)

19 STEW PETERS: Welcome back to the Stew  
20 Peters show. We are here with @Johnheretohelp,  
21 formerly Dr. Jonathan McGreevey, a credible  
22 whistleblower who has verified and validated the  
23 transcripts of the interviews that Lin Wood has  
24 produced and released.

1                   We talked about the stolen election. Is  
2 there anything that we missed there? Are there any  
3 names specifically that you want to name here who  
4 coordinated this domestically?

5                   JONATHAN McGREEVEY: Well, I mean,  
6 everybody up through Pence had a part in it. I  
7 mean, he's manipulated. He's controlled. He's  
8 always kowtowed to Pelosi his entire career. I told  
9 them prior to the certification he wasn't going to  
10 do it. He couldn't. And he's been paid off. He is  
11 now being promoted for a presidential role, which  
12 I'm looking forward to.

13                  STEW PETERS: Is there truth to the fact  
14 that Pence is involved with child sex trafficking?  
15 Is he a pedophile?

16                  JONATHAN McGREEVEY: Yes. Yes, he is. The  
17 young men that I mentioned in Lin Wood's  
18 interview -- and I'm speaking to Pence right now.  
19 Let's test Mike Pence's memory.

20                  Hey, Mike, do you remember when you  
21 betrayed President Trump and the entire country just  
22 a few weeks ago? Probably not. Do you remember a  
23 young man named Jeremy from about six years ago?  
24 Because we do, and we know where he lives and he

1 remembers you. So he's on and he's (indiscernible)  
2 now, but I'm really looking forward to your  
3 presidential run. So you know, they say karma wears  
4 silver board shorts but, you know, whatever.

5 STEW PETERS: I don't know about -- you  
6 know, you're a constitutional scholar. I don't know  
7 about that. I don't know if you have the answer to  
8 this. I don't know what we are going to do to fight  
9 or reverse this.

10 But you can unequivocally 100 percent say  
11 that Joe Biden is not the legitimate president, so  
12 is any action, any executive action, any executive  
13 orders, any legislation that's happening right now,  
14 is any of it legal? Is any of it official?

15 JONATHAN McGREEVEY: No. It carries no  
16 weight for the people, for the constitution or  
17 anything. It's like I said. If I broke into a bank  
18 and took over and bribed the guards and threatened  
19 everyone, it doesn't make me the bank president,  
20 okay? (Indiscernible) the vault and change anything  
21 I want. Nothing is legal. They can change it all  
22 because they know that it will have a lasting  
23 effect. Even if President Trump came back tomorrow,  
24 it's going to have a lasting effect which is why

1 certain persons are not going to the southern  
2 border. It's not a crisis for them. That's exactly  
3 what they want, and they want more and more and  
4 more.

5 And there's a ton of money going south to  
6 Central and South America to transport these people  
7 in from all over. They're coming up here. I mean,  
8 they're not walking. They're being transported.  
9 It's a nonstop human train coming in because this is  
10 what they want.

11 They know -- like I said, if President  
12 Trump is back tomorrow, you've got how many millions  
13 of new people in? And they're not going to get them  
14 all out. They know this. This is why they want  
15 every day -- every day is a victory for them until  
16 they lose their grip on their phony presidency. And  
17 the sooner the better.

18 STEW PETERS: We briefly eluded to  
19 hundreds, if not thousands, of political prisoners.  
20 They're currently being jailed. They're being  
21 mistreated. They're tortured from what we  
22 understand. They're in solitary confinement.  
23 They're not allowed phone calls. They haven't been  
24 charged with anything. Those that have been charged

1 with misdemeanors are still facing decades in prison  
2 for what happened on the 6th of January at our  
3 Capitol. Which, by the way, is now vacant. Nobody  
4 is there. Washington, D.C. is a ghost town. I'm  
5 not quite sure that there's nobody actually at 1600  
6 Pennsylvania Avenue inside of the White House.

7 Can you speak to that? Do you know why  
8 Washington, D.C. is vacant? Why is the FBI boarded  
9 up?

10 JONATHAN McGREEVEY: Well, the FBI wants to  
11 support the house (indiscernible) everything is and  
12 how the attacks are bad and white terrorists are  
13 going to attack them. So they're -- this is their  
14 form of solidarity. They want to appear as they're  
15 victims as well. We're doing our best. We are  
16 investigating this with our normal level of  
17 integrity, but it makes us a target so we're boarded  
18 up.

19 They portray themselves as victims, but  
20 they were complicit and they helped. And there's no  
21 reason to have a whole bunch of people in D.C. when  
22 you have five or six people running the entire show  
23 and just handing out orders.

24 STEW PETERS: Who are the people that are

1 running the show and handing out orders?

2 JONATHAN McGREEVEY: Pelosi is at the top.

3 She did not become the legitimate Speaker, as I  
4 mentioned. In 2018, they had to get balance on  
5 President Trump so they cheated enough to get enough  
6 seats to control Congress.

7 She's been an illegitimate Speaker.

8 (Indiscernible) of the BS impeachments were all  
9 illegitimate. So was the Russian collusion. It's  
10 interesting how that started. It was actually the  
11 Russian and Israeli people floated a lot of fraud.  
12 They didn't change anything, but they did work a lot  
13 of the fraud coming or attempted fraud. They just  
14 stopped the fraud from occurring. Didn't change  
15 anything. And this is why they immediately screamed  
16 Russian collusion, Russian collusion. That's how  
17 that started.

18 And because they shut it down and blamed  
19 them and make it look like -- they knew they stopped  
20 their fraud, but they're going to blame President  
21 Trump for it and say they helped them. They  
22 reversed it. They blamed him for what they had  
23 done.

24 STEW PETERS: Is it common knowledge in

1 Washington amongst congressional members of  
2 Congress, is it common knowledge amongst senators,  
3 is it common knowledge throughout our entire  
4 government that this election was stolen and that  
5 Nancy Pelosi is an illegitimate Speaker and that  
6 Mike Pence is a pedophile and that Justice Roberts  
7 is a pedophile?

8 Is all of this stuff common knowledge by  
9 those so-called elected representative, by  
10 politicians, by people in power? Does everybody  
11 know this to be true and correct?

12 JONATHAN McGREEVEY: Yes, they know it and  
13 they -- that's the way they want it. It's like, you  
14 know, what good is a wild card in there? What good  
15 is it to elect someone that you don't know or that  
16 you don't control? Then you have to fight them.  
17 You have to expand your process. You have to put  
18 money and effort into convincing them or something  
19 like this. It's easier if you control them.

20 And they're controlling themselves by their  
21 own disgusting behavior. So you control them now.  
22 When you need something signed, if you need a  
23 decision in court and it's important to you, you  
24 don't have to make any effort. You don't have to

1 expend money and bribe them and -- you already  
2 control them. They're in your pocket. You just  
3 don't even have to remind them really. You just put  
4 it through and you expect it to be fine.

5 STEW PETERS: So 100 percent in Washington,  
6 Republicans alike, America first so-called patriots,  
7 all of them know?

8 JONATHAN McGREEVEY: Certainly. It's  
9 obvious. I mean, anybody with common sense can see  
10 that it's wrong. A lot of republicans -- most of --  
11 this is one of the reasons that I've actually  
12 started running.

13 I mean, I'm going to bring it up, but too  
14 many politicians tell you all the time, "I'm going  
15 to win my race." "I've won the election," and then  
16 it becomes all about them because they think they  
17 won something and they deserve a prize. It's not  
18 about the people. It's not about their duty and  
19 what they swore to protect. It's not about the  
20 country as a whole. It's about them because they  
21 won. They're special now.

22 And that's the attitude they have, and it  
23 all becomes about them. So you get in there and  
24 there it is. This is how it is. This is how it's

1       been. They're not going to go in and try and change  
2       it. They want what they want. They want their  
3       piece of the pie. They want to be on the inside for  
4       a change.

5                   STEW PETERS: Let's talk about the January  
6       6th insurrection. What do you know?

7                   JONATHAN McGREEVEY: Oh, I did write a  
8       thread on Twitter that was very well received --  
9       thank you everyone -- that listed the stuff and who  
10      the shooter was.

11                  Now I can tell you here about the  
12       information I received to write that thread. It was  
13       corroborated by two FBI agents and one Secret  
14       Service agent. I corroborated it three times before  
15      I put it up.

16                  You can see the shooter. You can see the  
17       video. I'm going to tell you a couple parts that  
18       are not on the thread and that was talked about.  
19       You know what happened. They're not releasing the  
20       thousands of hours of video. Other countries have  
21       it. I'm hoping that the family of Ashli Babbitt can  
22       request it in discovery because they're suing to get  
23       ahold of it somehow.

24                  And you'll see for the most part really

1 boring stuff. You'll see people just meandering  
2 around, just looking at stuff. You'll see people  
3 standing right there talking to the Capitol police  
4 and then just standing there on their phone for  
5 minutes on end; you know, a really violent  
6 insurrection.

7                   But they were losing control. This is why  
8 (indiscernible) towards the end. They were losing  
9 control. They needed the violence. They had tried  
10 to ramp it up before which goes back to the election  
11 fraud. They did not think that they could pull it  
12 off. They didn't think they could steal the  
13 election.

14                   Then they thought that if they did  
15 manage -- they knew they could get the final  
16 numbers. That was all set up. But they didn't  
17 think anybody would accept it. They felt the fraud  
18 would be uncovered quickly. They thought that  
19 President Trump would not leave until this was  
20 uncovered and the whole thing was falling apart.  
21 This is why they started that oh, he's not going to  
22 leave. He's not going to leave. Remember the  
23 rhetoric everybody was saying? That's why.

24                   And they couldn't believe that they

1 actually got it and that he was leaving. They were  
2 stunned. They were absolutely stunned that patriots  
3 didn't take to the streets and shut down the  
4 country.

5 STEW PETERS: Two FBI agents and a Secret  
6 Service agent corroborated the fact that this thing  
7 was 100 percent a setup. Who set it up?

8 JONATHAN McGREEVEY: It was Pelosi. She  
9 wanted it there. She had controlled it and she had  
10 a lot of help. The thing was -- now there were FBI  
11 agents. There were federal agents all over January  
12 6th. They were all over the place. And they were.  
13 One of the persons who corroborated this was there.  
14 They set this up. They needed a thing because  
15 everybody wanted to stand up and use this.

16 It's the same thing with the bombers; you  
17 know, the bombs that were placed. And the FBI knows  
18 who they are because I'll put it right out here  
19 publically. I know who they are. And I can tell  
20 that you the person who orchestrated the bomber and  
21 the devices has a direct connection to the DOJ.

22 STEW PETERS: Who is it?

23 JONATHAN McGREEVEY: And they were both  
24 taking their orders -- what's that?

1 STEW PETERS: Who is it?

2 JONATHAN McGREEVEY: He's related to a DOJ  
3 official.

4 STEW PETERS: Do you want to name these  
5 people?

6 JONATHAN McGREEVEY: Not that one. Not  
7 yet. But he's related to a very high-ranking judge.  
8 Anyway, so they know who they are, but it's more  
9 valuable to them to keep the myth going. Oh, this  
10 is a terrorist, a white terrorist, and there's a  
11 bomber out there so we have to keep our building  
12 closed. I mean, they're placing bombs. We could be  
13 a victim.

14 Well, they know who it is. They supplied  
15 the crappy device that didn't work. But you know,  
16 we have to keep boarded up because there's a bomber  
17 out there. We can't find him. They know who they  
18 are. I've got a picture of him on my phone. So  
19 they know all this, and it's just to keep it going.

20 Now Pelosi, who is masterminding this  
21 stuff, really stepped out from behind the curtain to  
22 do this. Normally she works through patsies and she  
23 did to an extent on this one, but she didn't trust  
24 anybody to get it right. She even called in the

1 orders to get someone to sacrifice.

2 Now if you get these videotapes, you'll see  
3 them running around questioning people, leading  
4 them. They were leading other people up to the  
5 stairs, and they didn't go that far because  
6 (indiscernible) whatever scared them. They felt  
7 something was wrong and they just backed off, went  
8 the other way. You'll see these on there.

9 They finally got someone up there,  
10 Ms. Babbitt, and you'll see the shooter and you can  
11 actually see in the video -- watch it. As I  
12 described, you'll see him move forward, back off,  
13 move forward, back off because he's accepting his  
14 orders: "Who is it? Him? That one? That one?"  
15 And a lot of these people had their faces covered  
16 and things like that, so he wasn't sure who was  
17 male, who's female. He had to get an identification  
18 of who to shoot. There's a video recording of this  
19 because we know who he was talking to and we know  
20 who he was talking through.

21 STEW PETERS: Who was he talking to and who  
22 was he talking through?

23 JONATHAN McGREEVEY: He was talking to  
24 Pelosi's people, but you could not use the normal

1 communications. This is (indiscernible). There we  
2 go. You could not use the normal communication  
3 systems because the officers were all over the  
4 place, and there are people who regularly --  
5 including reporters but just general citizens --  
6 listen to police scanners and listen to the Capitol  
7 police to find out what's going on, get tidbits of  
8 info, whatever. Okay, they know this. This is how  
9 they get tips.

10 So you couldn't be talking through there.  
11 You couldn't have somebody say over the radio,  
12 "Shoot." It will be way too obvious. They also  
13 wanted to protect their phones and their  
14 transcripts. Now the FBI has taken all of those,  
15 but their text messages, things like that. So they  
16 were using military encrypted communications.

17 STEW PETERS: Dr. McGreevey, do you know  
18 who shot Ashli Babbitt?

19 JONATHAN McGREEVEY: (Indiscernible)  
20 online. I mean, that's him. He was the shooter. I  
21 forgot his name. I don't recall it. But I mean,  
22 the shooter that's on there, I mean, he is him.  
23 They knew what he looks like. They know who he is.

24 But the one who helped set this up, the

1 person who provided a lot of this -- Pelosi did not  
2 want the FBI coming into her house. You're not  
3 going to come into her house and do this and mess it  
4 up because that's her house. And that's how she  
5 refers to it: Her (indiscernible), her house.  
6 She's in charge. She has her own little secret  
7 gestapo police force, and they take the orders;  
8 however, they were using, like I said, military  
9 communications at the time, and they were provided  
10 by a certain person.

11 This person was rewarded for what was done.  
12 They helped set everything up. This is the same  
13 person who had a duty to protect everything and  
14 didn't because of his hatred of Trump and because he  
15 saw a way to get inside. And I'm putting this out  
16 there because I'm relying on this person's honor,  
17 his sense of duty to come forward.

18 STEW PETERS: So you're not going to name  
19 this person?

20 JONATHAN McGREEVEY: Oh, I'm going to name  
21 this one. I'm going to tell you who it is, but I  
22 would like to speak to him. I understand your  
23 hatred and you're entitled to your opinion, but you  
24 swore an oath, the same that many of us have more

1 than once.

2 You were paid off, okay? You got your  
3 ticket on the inside but you're not. You're not as  
4 safe as you think you are. You are a connection  
5 between what happened on January 6th, as fake as it  
6 is, and the federal agencies and Pelosi. You are a  
7 knot that's easily untied, okay? You have to think  
8 of that. And you know how these people are. You  
9 don't know the extent of it.

10 He's playing in a league that he's not used  
11 to. So I am speaking to Major General William  
12 Walker, the Commander of the U.S. National Guard in  
13 D.C. and the brand newly promoted Sergeant at Arms  
14 promoted by Nancy Pelosi.

15 So General, I would never attack our  
16 military. I would never besmirch someone who wears  
17 the uniform, especially a general officer. I am  
18 asking you, sir, to please stand up and defend us as  
19 you have done in the past. It's going to come out.  
20 I have heard that all of your private and social  
21 communications, e-mail, text, phone calls,  
22 everything have been archived for well over the past  
23 year, so I would implore you, sir, to do your duty  
24 and come out and defend us once more. You don't

1 realize the level that these people will go to to  
2 protect what they have.

3 STEW PETERS: Wow.

4 JONATHAN McGREEVEY: And this is the same  
5 Commander who denied President Trump's request to  
6 bring in the troops. Just look him up. You can  
7 find him easy.

8 STEW PETERS: We have so much more to  
9 cover. That took my breath away. We will be right  
10 back with more from Dr. Jonathan McGreevey.

11 (Break)

12 STEW PETERS: We are joined live by  
13 Dr. Jonathan McGreevey here. You know him on  
14 Twitter as @Johnheretohelp. I'm looking at an  
15 article right here. The headline says: Pelosi  
16 names DC National Guard Commander Major General  
17 William Walker to be House Sergeant at Arms.

18 Dr. McGreevey, this was a reward for his  
19 participation for providing the communication for  
20 not honoring the request of President Donald J.  
21 Trump to activate the military to allow for this  
22 so-called insurrection and ultimately the execution  
23 of Ashli Babbitt to continue; is that what I'm  
24 reading into this?

1                   JONATHAN McGREEVEY: That's correct.

2                   STEW PETERS: Why did Trump leave the White  
3 House?

4                   JONATHAN McGREEVEY: Because he's an  
5 honorable man, and he was not going to maintain it  
6 by violence. The Democrats had planned for him not  
7 leaving. They had planned for months-long protests.  
8 They were going to encircle the White House. It's  
9 easily verified.

10                  There were hotels all around booked solid  
11 (indiscernible) canceled when he left. You know,  
12 there are occupy White House or, you know, OWC type  
13 stuff that -- you know, coms that the domain names  
14 were purchased. They were ready for this.

15                  And when he did leave the White House, it  
16 was not (indiscernible). He did not lose. He  
17 shouldn't have and I didn't want him to. I know  
18 many people didn't. But he did it to prevent  
19 violence, to save lives, and to fight it in a  
20 legitimate court system, as corrupt as it is. But  
21 he did it the best possible/least damaging way  
22 possible. I didn't want him to, but he did it to  
23 prevent further damage.

24                  STEW PETERS: You named the Sergeant at

1 Arms, the Major General. What is your motivation  
2 for naming him?

3 JONATHAN McGREEVEY: Well, he was involved.  
4 He's known. As I said, I've heard that his  
5 communications, his texts, e-mails, phone calls,  
6 everything for well over a year have already been  
7 archived.

8 There's (indiscernible) motivation. My  
9 motivation is I want him to come forward and talk  
10 about the involvement. He is a direct connection to  
11 what happened on January 6th and how fake it is and  
12 to Nancy Pelosi.

13 He can give a month's worth of the  
14 communications setting all this up previously and  
15 how things changed when President Trump agreed to  
16 leave. They were ready for this big occupy White  
17 House and it changed.

18 But they needed something, and he was  
19 involved. He can tell you, you know, Nancy Pelosi  
20 wanted (indiscernible), all this stuff. But he  
21 provided the communications because Pelosi did not  
22 want the FBI running an operation in her house that  
23 she couldn't control and couldn't listen to, and she  
24 couldn't listen to their communications.

1                   STEW PETERS: What do you suppose or what  
2 do you know Pelosi to have offered the Major General  
3 in order to get him to go along with this?

4                   JONATHAN McGREEVEY: Well, he wanted a  
5 piece on the inside. He wanted to be inside. He  
6 wanted to be a player. He wanted to be in the big  
7 game. And he personally hated President Trump,  
8 which is his right, okay? The man is a General.  
9 He's entitled to his opinion. Absolutely. I'll  
10 defend that. But he let the hatred blind him.

11                  And this is not something I take lightly.  
12 I have respect for the uniform and anyone who wears  
13 it, and he's a General even. But he allowed his  
14 hatred to blind him and to get something he wanted.

15                  And they are master manipulators; however,  
16 he doesn't realize the position he's in. He's not  
17 safe. He's not one of them. He's not a  
18 coconspirator who's trusted. He is a knot that is  
19 easily untied if it gets too close to her.

20                  So I'm hoping, I'm praying, that he's  
21 (indiscernible) information all this time and do it  
22 one more time. Please, sir, just come out and let  
23 people know.

24                  STEW PETERS: Do you believe that by coming

1 out, he could help to protect himself?

2 JONATHAN McGREEVEY: Yes, absolutely. He  
3 doesn't realize the people he's close to and what  
4 they will do to protect it. He is no longer an  
5 integral piece of that day. He's a tiny little  
6 player who can be removed at any time.

7 And if they're trying to protect what  
8 they've done, protect themselves from being  
9 prosecuted for the crimes they've committed and keep  
10 control of the White House, do you think they'd  
11 hesitate for a moment? And he's the weak link.  
12 You're talking about Pelosi and --

13 STEW PETERS: Are you saying that they will  
14 kill him?

15 JONATHAN McGREEVEY: What's that?

16 STEW PETERS: Are you saying that they are  
17 capable of and would kill him without an issue?

18 JONATHAN McGREEVEY: Oh, I believe they  
19 would. Absolutely. He could just have a heart  
20 attack driving home. It would be very simple. He's  
21 in the nest of vipers and doesn't realize just how  
22 bad these people are. He's not one of them, and  
23 he's in between the massive FBI and the political  
24 machine around it and he's in between Pelosi. He's

1 the little guy in the middle, and he's not on equal  
2 footing.

3 STEW PETERS: Regarding January 6th,  
4 regarding the stolen election, is there anything  
5 that we have missed before we move into the very  
6 important COVID and the vaccines?

7 JONATHAN McGREEVEY: I don't think so. I  
8 mean, (indiscernible) put out so far. The shooter  
9 is the shooter. They're protecting him because if  
10 you get to the shooter, it would lead back to the  
11 communications, things like that.

12 The FBI like I said swooped in and took all  
13 the private communications they could, everything to  
14 make it look like that. They don't want anyone to  
15 ask about any military channels that were up. And  
16 of course, the National Guard encircled everything  
17 for months afterwards. Same thing.

18 STEW PETERS: So I just want everybody to  
19 understand the magnitude of this. The January 6th  
20 crime has been solved, and I hope that Ashli  
21 Babbitt's family is listening. I hope this gets to  
22 them.

23 And for every single American out there  
24 that watches mainstream media, legacy media, cable

1 news, broadcast networks, let it be known that the  
2 crime has been solved; that Nancy Pelosi was  
3 directly responsible for the assassination death of  
4 Ashli Babbitt, and those communications were offered  
5 up to that officer who in the video is the officer  
6 that took her life and that those communications  
7 were provided by the current Sergeant at Arms who  
8 you are imploring to come forward. Unbelievable.

9                   Let's move into COVID. Although it's  
10 really hard to breeze over this stuff, we have a lot  
11 to get to which is extremely important. This is a  
12 bioweapon. This was, in my opinion, a man  
13 engineered virus that was intentionally manufactured  
14 to be released upon the global community to inflict  
15 fear, to bring in the real killer which is the  
16 vaccines. Is that an accurate depiction of what  
17 this COVID-19 is?

18                   JONATHAN McGREEVEY: Yes, it is a weapon  
19 without question.

20                   STEW PETERS: How do you know this,  
21 Dr. McGreevey?

22                   JONATHAN McGREEVEY: I've spent my life  
23 designing weapons and in that field as well. Gain  
24 of function research is something one of my

1 doctorates was based on. It's -- gain of function  
2 is normal. It's not a bad thing. It is when you  
3 have idiots like this.

4 You could mutate something. It doesn't  
5 have to become a weapon. It could be a carrier.  
6 Viruses are very good at getting into parts of the  
7 body or getting into an organ or getting here and  
8 there and they could carry medication. Get a virus  
9 that infects cancer cells. All right. Now we're  
10 talking.

11 So it's important and it's good medical  
12 research. But just like a firearm, it can be used  
13 for protection or by a criminal, and what you have  
14 here is a bunch of criminals.

15 Tony Fauci is a nasty, nasty piece of work.  
16 He is not a big man and he hates that. Anyone  
17 larger than him he immediately hates. But  
18 intellectually, he's not very bright. He is at most  
19 an administrator.

20 And what you see here is a kid who put  
21 together a zip gun and he's running around and he's  
22 dangerous. COVID is not that well engineered. It's  
23 quick, quick and dirty, but it's effective for what  
24 they needed.

1           There are other versions. Wuhan just  
2 (indiscernible) all their records. They are --  
3 there's a bunch. There's more coming. This was  
4 just the most promising version.

5           He has done this throughout his career.  
6 When someone who was smarter than him or, you know,  
7 who was better at something than him, he would stomp  
8 them down, blackball them, stall their research.  
9 He's taken research from very gifted, dedicated  
10 researchers and physicians in the past and he's  
11 taken research, stalled them when they sent it for  
12 approval, sent it for review, things like that.

13           He'll take it, stall it and give it to  
14 other people and they promote it. They publish it,  
15 and they get credit and he benefits financially.  
16 And as soon as he has something viable -- which  
17 they've tried to get things before. They have tried  
18 to get bioweapons before that would achieve specific  
19 goals they wanted with the population.

20           STEW PETERS: Now you were directly  
21 involved with one of those particular viruses, am I  
22 right?

23           JONATHAN McGREEVEY: Yes.

24           STEW PETERS: You developed a virus. What

1 would that virus have done if it had been released upon  
2 the world?

3                   JONATHAN McGREEVEY: This was gain of  
4 function research, one of many, and this one -- I  
5 probably shouldn't say which virus, but it was a  
6 (indiscernible) virus you heard about but it was  
7 manipulated and engineered, gain of function, to the  
8 point where it would affect populations by making  
9 people sterile.

10                  If it had been released within one  
11 generation, it would have made 90 to 95 percent of  
12 the male population sterile and approximately 30-35  
13 percent of the female population sterile.

14                  STEW PETERS: 90-95 percent of males in one  
15 generation would have become sterile; is that what I  
16 heard you say?

17                  JONATHAN McGREEVEY: Yes.

18                  STEW PETERS: What happened to this  
19 research? What happened to this virus?

20                  JONATHAN McGREEVEY: They tried to get it.  
21 Gates -- Bill Gates tried to purchase it. Fauci  
22 tried to steal it. When it became evident that they  
23 were very, very serious at not only acquiring it but  
24 basically diluting it and releasing it so that it

1       would be half as effective with no guaranty that it  
2       would be half, that it was destroyed. The research  
3       was buried and the rest of it was destroyed and they  
4       could not get it, and they basically tried to  
5       blackball the person as much as they could.

6               STEW PETERS: So just so everybody's very  
7       clear here, this is a virus that would have  
8       essentially wiped out an entire generation by making  
9       90 to 95 percent of males sterile and 30 to 35  
10      percent of females would become infertile, unable to  
11      reproduce.

12              Anthony Fauci and Bill Gates tried to buy  
13      this. Gates tried to buy it. Fauci tried to steal  
14      it with the intent knowing what it was capable of of  
15      releasing it into the general global population; is  
16      that right?

17              JONATHAN McGREEVEY: That's correct. Rod  
18      Rosenstein tried to seize it legally. His sister,  
19      Nancy, was very interested in it and also tried to  
20      help him. She was going to point out what to look  
21      for and how to get it and whether this was real or  
22      this was not. She was the one directing them  
23      because Rod is not a physician or scientist. And  
24      they tried very, very hard to get it.

1                   Now their intent from what people said was  
2 they would dilute it, like I said, to about half the  
3 effectiveness and wipe out half of the population by  
4 making one generation sterile. You could not  
5 reproduce.

6                   STEW PETERS: When it was destroyed, is  
7 that when Fauci and Gates became desperate and that  
8 is when COVID was designed?

9                   JONATHAN McGREEVEY: Well, this was three,  
10 four years before that. They had been looking  
11 anyway for something with population potential and  
12 that's how they worded it, something with the  
13 potential for population control, just one way or  
14 another.

15                   They don't want to reduce it as much as  
16 everybody thinks. I mean, personally they would  
17 like that, but they need things to work. They need  
18 systems to work. It's no good being the richest man  
19 on the planet with two people. Who cares.

20                   They don't want that right now. They want  
21 to usher in everything by reducing it over time.  
22 They've bragged about it. There have been movies  
23 about it, and this is their intent. It's  
24 (indiscernible). I mean, this is what they tried to

1 do. (Indiscernible) would have done it without  
2 question because it makes sense. There's already a  
3 natural occurring virus that can have this effect.  
4 It was just made multitudes more effective.

5 STEW PETERS: We are discussing everything  
6 with @Johnheretohelp, Dr. Jonathan McGreevey. We  
7 have touched on COVID. We're going to come back  
8 with more of that as well as the vaccine and what  
9 its real intent is, what is its real purpose when we  
10 come back. Stick around.

11 (Break)

12 STEW PETERS: \$1 billion last evening  
13 during our text conversation is what McGreevey told  
14 me that Gates was willing to pay for a virus that  
15 Fauci wanted to intentionally release on the world  
16 that would wipe out an entire generation. 95  
17 percent of males would be sterile. 35  
18 percent/upwards of 40 percent of females would be  
19 infertile. These people are sick. They are the  
20 epitome of Satan personified.

21 (Break)

22 STEW PETERS: @Johnheretohelp, that's how  
23 you know him on Twitter. His real name,  
24 Dr. Jonathan McGreevey. He is here naming names,

1 telling all. We touched briefly on COVID. We  
2 obviously are under a clock here. I could talk to  
3 you, Dr. McGreevey, for days, and I'm sure that  
4 listeners will critique this by saying, "I don't  
5 know why you didn't let him talk longer." Well, we  
6 have a certain time slot that we are allotted, and  
7 I'm sure that we will get you back again to talk  
8 more about this.

9                   We talked about COVID, its intentional man  
10 engineered function. We talked about the vaccine  
11 and the rolling out. What is the real plan for the  
12 vaccine? What do they want from this vaccine? What  
13 results are they looking for? What benchmark of  
14 achievement are they searching?

15                   JONATHAN McGREEVEY: Well, you'll hear  
16 certain politicians, governors, we must get 50-60  
17 percent or more of the population vaccinated. Well,  
18 that would reduce the population by a great deal.  
19 Not kill them, not going to die, but they'd be  
20 debilitated. (Indiscernible) Alzheimer's; you know,  
21 a young lady with dementia. It's horrible.

22                   So many of us have had to, you know,  
23 take -- everyone, of course, but take care of an  
24 older relative, a loved one with these conditions

1 and it's horrible. They can't take care of  
2 themselves. And to see their mind go, it's like I'd  
3 rather lose a limb or something than your mind.

4                   And that's what it does, and there's  
5 system-wide damage. There's organ damage.  
6 (Indiscernible) system. But overall, the effect is  
7 neurological from what we've seen. And half the  
8 family -- there's a family of four again. Look  
9 around. Which one of you got the right vaccine?  
10 Which one of you got one of the bad ones?

11                  One, two, three of you are now disabled  
12 mentally. I'm quite certain if you have an 18 year  
13 old with Alzheimer's, they're going to vote  
14 Democrat, I'm certain.

15                  But you know, you still have to care for  
16 them. Their care is 24/7 nonstop and expensive.  
17 You're going to be dependent on the government. Get  
18 50-60 percent of the people vaccinated or more,  
19 70-80 percent. We want them all because over half  
20 the people are going to be dependent on the  
21 government for care. The other half are going to be  
22 taking care of them, and that's what they want.  
23 They want everyone dependent in one form or another  
24 on the government. (Indiscernible) is already here.

1 STEW PETERS: Right.

2 JONATHAN McGREEVEY: You don't even have to  
3 announce it.

4 STEW PETERS: You have been an integral  
5 part of doing the research and developing some of  
6 these things. That is why you're able to speak from  
7 an educated perspective on this. I want people to  
8 understand that this is what you do. This is your  
9 profession. This is what your expertise is in; is  
10 that correct?

11 JONATHAN McGREEVEY: Part of it. At the  
12 time, yes. I mean, it's molecular biology,  
13 molecular chemistry in addition to the medical, so  
14 yes. I mean, that's what I did. That's part of  
15 what one doctorate was based on was gain of function  
16 research.

17 I've had to bump into Fauci many times  
18 since the '80s, and he's had a 30-year  
19 (indiscernible) off and on. But I mean, he just  
20 can't control himself, and he's a nasty, nasty  
21 person. Anyone who's physically bigger than he is,  
22 he automatically hates them. Anyone who's  
23 intellectually smarter than he is, he immediately  
24 hates them and wants to destroy them. He's done

1 this in many ways. He's blackballed people.

2 You have very gifted dedicated men and  
3 women researchers/physicians pour their heart into  
4 something to save lives. They'll bring it to him  
5 and if it's good, if it's something you can  
6 understand, he'll stall them, stall the opinion,  
7 stall approval and give it to someone else, just  
8 flat out steal it. If it's something dangerous,  
9 he'll move it on.

10 But he always informs the people who pay  
11 his bills what's going on because they're always  
12 looking for something they can use to further their  
13 goals, and they have found one.

14 COVID is engineered without question. It  
15 is not very well engineered. It's like a puzzle  
16 with other puzzle pieces stuck in it, and you can  
17 see them. But it's effective. The truly damning  
18 part would be the vaccine. That's easier, and  
19 that's what they're getting.

20 I use the analogy to a lot of people,  
21 military, police, law enforcement, everything. If I  
22 took a 1911, standard 1911, and I say  
23 (indiscernible), details stripped, every last screw.  
24 Put it in a box ship, it out. Open the lid. Say

1 what's that? Close it. You can tell me it's a  
2 firearm. Some of you could put it back together,  
3 and a few gifted specialists could make it better,  
4 improve upon it, customize it. That's what they're  
5 doing.

6 That's the level you're at with the virus.  
7 It's normal. Gain of function research is  
8 important. It's something that's normally done. Do  
9 it for research because let's say it's a virus.  
10 Viruses are really good at getting into the body,  
11 getting into certain areas. What if you got a virus  
12 that would carry medicine into a cancer cell? What  
13 if you could give a tumor a virus and kill it?  
14 That's what you want.

15 But you also get bad results. You get  
16 results that could be used as a weapon, and that's  
17 what they're doing. They've cobbled together a zip  
18 gun and are running around with it and it's  
19 dangerous.

20 STEW PETERS: Do you know what's in these  
21 vaccines?

22 JONATHAN McGREEVEY: It's the vaccine  
23 itself. It's like the COVID but much higher  
24 version, much more concentrated, much more deadly

1 version because it's easier to make.

2 STEW PETERS: So the virus is in the  
3 vaccine? The vaccine is the virus but in a  
4 concentrated form?

5 JONATHAN McGREEVEY: Right. I mean, they  
6 introduced HIV so it fools the body. The body  
7 doesn't recognize it. If they inject it and you  
8 immediately go into a reaction, then your body  
9 starts fighting it. Here we go.

10 But if I can suppress the immune system,  
11 make sure it's all the way in there -- and they put  
12 in different things that will get it through. They  
13 put in this basically to make it suppress the immune  
14 system. That way it can go in and your body  
15 wouldn't recognize it and boom, there you go.

16 STEW PETERS: What is your theory on  
17 shedding and transmission? They knew that there  
18 would be vaccine hesitancy. They have told us for  
19 many years that they were going to do  
20 self-transmissible vaccines, vaccines that were in  
21 essence contagious.

22 People are experiencing side effects that  
23 are around vaccinated people although they are not  
24 vaccinated themselves. We're talking irregularities

1 in menstrual cycles. We're talking about headaches,  
2 fatigue, things like that.

3 Are the non-vaccinated people that are  
4 subjected to vaccinated people essentially becoming  
5 vaccinated? Are they hopelessly lost as well?

6 JONATHAN McGREEVEY: No, they're not  
7 hopelessly lost. Yes, they are being exposed.  
8 There is shedding in many disease. I mean, herpes  
9 sheds. That's why you can catch herpes from someone  
10 that's not having an outbreak. That's normal, how  
11 it happens.

12 COVID and SARS, there's a horse version as  
13 well, and that's shed through fecal matter. You're  
14 having this one -- the vaccine, because it's so  
15 concentrated, your body is replicating it so much  
16 that it's coming out everywhere. Your hands could  
17 be dirty. You know, people are (indiscernible).  
18 You could have fecal matter on your hands. Your --  
19 you know, the fluid in your system, you're sneezing,  
20 you're coughing, things like that, and it's in the  
21 air.

22 Now a lot of that would be most likely  
23 psychosomatic if you know it was like you don't want  
24 the vaccine. You know there's something wrong with

1 it, and there is. You're not wrong. But if you  
2 know the person is vaccinated, you're like ah. A  
3 lot of it would be psychosomatic. But there are  
4 going to be legitimate things because it's so  
5 concentrated.

6 It's like -- you know, think of it as  
7 perfume. If you put on some perfume in the corner  
8 and you're all the way across the room, you might  
9 get a little whiff of it. Okay. If somebody comes  
10 in the room and pours it right next to you, it's  
11 going to be overpowering, and this is what you're  
12 working with now.

13 The person has it in their system and it's  
14 replicated so much, they're giving off like an aura  
15 of it, like they're greasy and they're body is  
16 expelling it because their body is fighting it but  
17 it's been suppressed so it's replicating and your  
18 body's like what's this and it's trying to deal  
19 with.

20 And it's kind of like somebody who's  
21 sweaty, working out next to you. You can feel their  
22 body heat. You can smell the sweat. You know, not  
23 saying they stink or anything, but that's what it's  
24 doing and they're close to it.

1                   So some of that's going to be just mental,  
2 of course, because people are so concerned about it  
3 and should be. But there are going to be instances  
4 where it's exhaled, where it's secreted through the  
5 system because there's so much and it can get you.  
6 You could pick it up from that.

7                   This was discussed actually way over a year  
8 ago when I wrote a thing about -- they called it a  
9 vax card back then, vaccination card. So they  
10 wanted a vaccination card which is now called a  
11 COVID passport or an immunization vax passport.

12                  And I don't remember where a year ago  
13 because this was part of their intent where they  
14 wanted the vax card, the COVID passport to  
15 completely be the top of the line, the ID. They  
16 wanted it to go past the state ID, the passport  
17 because you cared about the country. You cared  
18 enough to get vaccinated, so your vaccine passport  
19 is the only ID you need for any government service  
20 or to vote.

21                  They were trying to delegitimize the  
22 passport, driver's license, anything. They wanted  
23 this to be the ID. I wrote about it well over a  
24 year ago because this was a big part of the plan.

1 They loved that part.

2 There's also a part that again over a year  
3 ago where there would be COVID refugees and people  
4 who were permanently disabled for just being exposed  
5 to COVID or having COVID or the vaccine or being  
6 exposed to people with the vaccine, and again, way  
7 over a year ago before any of this came out, before  
8 the vaccine was even available because they knew  
9 this was coming because it was their intent.

10 And you were permanently unemployable, you  
11 couldn't work, you'd be permanently sick, and these  
12 COVID refugees were again dependent upon the  
13 government.

14 And this is their goal, dependency on the  
15 government, soften you up, shortages on everything,  
16 food, electricity, ammo, medication, fuel. We're  
17 seeing it all the time, and they're not stopping.  
18 They said it's a problem. They say it's a hack and  
19 yet it continues.

20 STEW PETERS: It's amazing to me that the  
21 general public is aware that Dr. Fauci predicted a  
22 pandemic or a breakout, that he predicted that it  
23 would happen during the Trump administration, and  
24 people still call this a conspiracy theory.

1                   Is it your belief or do you have knowledge  
2 of whether or not people like Barack Hussein Obama,  
3 Anthony the criminal liar Fauci, illegitimate Joe  
4 Biden, have these people received the vaccine? I  
5 mean, they've rolled up their sleeve on national  
6 television. Are they not getting the vaccine?

7                   JONATHAN McGREEVEY: No, no. I mean, you  
8 could, you know, wonder, maybe hope a little bit  
9 that they got one of the bad ones, but I don't wish  
10 anything like that on anyone.

11                  However, they didn't get the vaccine.  
12 These people think way too highly of themselves to  
13 risk that, especially when they know what's coming.  
14 This whole COVID thing and the vaccine especially  
15 was supposed to happen in Hillary's second term.

16                  You know, like I said, imagine the hysteria  
17 of the nonstop media, nonstop lockdowns, the massive  
18 changes in laws under the second term of a Hillary  
19 presidency as opposed to President Trump who was  
20 trying to do the right thing every day. I mean, it  
21 would have been completely night and day. And look  
22 at what they're doing now. Just magnify it by a  
23 thousand times.

24                  STEW PETERS: When we talk about

1           politicians that are supposedly for us, we as  
2           patriots, we as America First people, red pill  
3           people, we identify with a certain group of people  
4           that we believe are there for us; Paul Gosar, Matt  
5           Gaetz, Jim Jordan, and I'm naming a few of probably  
6           a half a dozen.

7           What about these people? Have they  
8           received the injection? Do these people all know?  
9           Is everybody complicit in this? Is everybody  
10          keeping this from the American public? Is everybody  
11          taking some sort of a saline or fake faux injection  
12          on television knowing exactly what it is that it's  
13          doing? Are they 100 percent everybody in government  
14          in on this?

15           JONATHAN McGREEVEY: No, not at all. And I  
16          really hope they did not take the vaccine at all.  
17          If they did, I hope they got one of the neutral  
18          ones. But if they did, they did it with the best of  
19          intention to support people. It's like fear is  
20          rampant. People are violent over not wearing a  
21          mask, not getting the vaccine. I mean, actually  
22          violent because they're so scared.

23           And they can stand up there and say, "Okay,  
24          look. I'm getting it," and then that will calm a

1 lot of people down. It will calm people down. It's  
2 like okay. Got it. I've got my scaredy blanket.  
3 I'm calm now. I've got my vaccine. I'm good. It  
4 stops some of the fear.

5 They'll still get nasty if you're not  
6 wearing a mask or you don't care about me blah,  
7 blah, blah, but it stops a lot of that. So as  
8 leaders, they were doing the only thing they could  
9 at the time to help save lives, to help calm people  
10 down. And if they put themselves at risk to do it,  
11 it's sad but more commendable.

12 STEW PETERS: Dr. Jonathan McGreevey is  
13 with us. We are out of time in this particular  
14 segment. We're coming right back. We are going to  
15 talk specifically about that, who is here to fight  
16 for us, how they can fight, and what is next for  
17 Dr. McGreevey. We'll be right back.

18 (Break)

19 STEW PETERS: Coming up next, we will talk  
20 to Dr. McGreevey about his plans, his run for the  
21 United States Senate as well as who else is stepping  
22 up and how.

23 (Break)

24 STEW PETERS: We are back with

1 @Johnheretohelp. That's how you know him on  
2 Twitter. His real name Dr. Jonathan McGreevey, not  
3 Ryan White. That is the name that he was forced to  
4 adopt for obvious reasons for cover and so on and so  
5 forth.

6 We have talked about the stolen election.  
7 We have talked about the January 6th insurrection.  
8 We have talked about Major General Walker. We have  
9 talked about Nancy Pelosi and her complicity. We  
10 have talked about the pedophilia of Vice-President  
11 Pence, the illegitimate House Speaker position. We  
12 have talked about COVID. We've talked about the  
13 injection. We have exposed Anthony Fauci. We have  
14 exposed Bill Gates.

15 What have we missed? What do you want to  
16 make sure that everybody knows before we go on to  
17 how to fix this, how to react to this and who can  
18 help stop it?

19 JONATHAN McGREEVEY: Everyone is aware of  
20 the audits that are happening in different states,  
21 and they're going to plainly show the fraud. They  
22 need to continue because it was system wide but  
23 especially in those states, and that's really all  
24 you need to prove it.

1                   January 6th was to cement everything in, to  
2 give them their excuse to crack down. You can see  
3 everything they're doing. I would like the elected  
4 officials -- Senator Paul, Senator Cruz and  
5 others -- to look into -- officially request these  
6 records now that they know they exist.

7                   I'd like the family of Ashli Babbitt who is  
8 fighting this to request them in their court case in  
9 discovery. (Indiscernible) to look for the  
10 military. The FBI is playing games. That's all  
11 they do. "We don't have any communications that  
12 reveal anything like that. There's no orders,  
13 anything like that." Of course you don't because  
14 they went through the military. You took all the  
15 civilian stuff. You're playing word games like you  
16 always do.

17                   STEW PETERS: If you were talking to the  
18 family of Ashli Babbitt, to Senator Paul, to Senator  
19 Cruz right now or anybody else willing to fight and  
20 ask for something specific, once again, what exactly  
21 specifically is it that you're asking them to do?

22                   JONATHAN McGREEVEY: Overall? Ask everyone  
23 to hold off on the vaccine, please. Save lives  
24 right now. Request something official in the

1 investigation, something. The January 6th stuff is  
2 going to fall apart along with the audits are going  
3 to prove the fraud. It's going to happen.

4                   Talk to that man, appeal to his sense of  
5 honor, and hopefully he'll go along with it. It's  
6 going come out. It's not hidden. It's not done and  
7 over with as they tell him and protect him. He is a  
8 loose thread between Pelosi and her power base and  
9 the FBI, and that's a bad place to be.

10                  STEW PETERS: The Honorable William J.  
11 Walker, Major General and current Sergeant at Arms,  
12 Senator Cruz, Senator Paul, anybody else if you are  
13 listening -- we know that you do -- please, please,  
14 appeal to his sense of honor and protect this man.

15                  This is real. I mean, this is real. If  
16 you don't think they will get to him, they  
17 absolutely will. I don't want that to happen, and  
18 obviously Dr. Jonathan McGreevey doesn't want that  
19 to happen either.

20                  There are many elected representatives that  
21 are out here that seem to be fighting for us,  
22 Dr. McGreevey. Our salvation can be found in part  
23 due to the efforts of these people, these America  
24 First people specifically. We have to be careful

1 about that because there are America First imposters  
2 out there who have adopted this creed in order to  
3 further the power and control of the deep state  
4 cabal that wishes to topple our political system,  
5 but there are a few that are out here fighting  
6 amongst us that are real, that are genuine.

7                   What specifically can they do right now to  
8 help stop what is this seemingly stop-less train  
9 that is headed down the tracks for this Marxist coup  
10 to complete itself?

11                   JONATHAN McGREEVEY: Protect yourselves.  
12 Stay healthy. Stay sane. Keep your faith very  
13 close to you. Communicate with your elected  
14 officials. There are some. You know who they are.  
15 They're fighting.

16                   You're going to have to discern who to  
17 support and who's America First, who isn't, who  
18 values life over themselves. You know there's not  
19 many like that. They put themselves first before  
20 anything else. It's a self-preservation thing. We  
21 all have it.

22                   But they're in a position. It's their job  
23 to put us over all as a whole, and they're not doing  
24 it. And we know who they are. We can figure it

1 out. So support the people who do support everyone,  
2 who value life, who value our country and the people  
3 who support them.

4 Stay together. They want you divided.  
5 They want you to hate each other. All this talk  
6 about race and color and everything, nobody ever  
7 mentions the color blue. Every one of us out here  
8 no matter what you think, all of us are floating  
9 around on a blue ball together.

10 It's ridiculous that we kill and hate each  
11 other over less than 2 percent difference. We  
12 should be celebrating that. Like tell me why you're  
13 different. I want to know. What kind of food do  
14 you eat? Where are you from?

15 But it's completely reversed, and that's  
16 the way they want it. They want you to hate and  
17 kill each other. We're almost identical. It's  
18 mind-boggling. But it's for a reason. It's for a  
19 purpose, and it's for their power and their position  
20 and their money.

21 STEW PETERS: And it seems to be really  
22 predictable. You know, I mean, it seems to be all  
23 part of the plan. We've seen this in history. And  
24 history, if you don't jump out in front of it, it's

1 bound to repeat itself.

2 All right. This is very exciting for me.

3 On your Twitter handle, a lot of people they see the  
4 John U.S. Senate candidate. This is not a joke.  
5 This is for real. You are running for the United  
6 States Senate and tell us about that. Make the  
7 announcement.

8 JONATHAN McGREEVEY: Well, yes. Okay. My  
9 name is John McGreevey. I am running for the United  
10 States Senate for the State of Maryland. I'm  
11 running for a seat that's currently occupied by  
12 Chris Van Hollen. It's certainly legitimate. I'm  
13 registered with Federal Elections Commission. I'm  
14 registered with the State of Maryland.

15 I'm a legal candidate. I have quite a bit  
16 of experience. I have over 40 years of putting  
17 America first, even to my own detriment, and it's  
18 the least I could do. Other people have paid much  
19 more.

20 But I have to come out front. I've worked  
21 on campaigns. I have family that has held political  
22 office at various levels, and I've worked in  
23 different campaigns at different levels. I've  
24 worked on campaigns for both Democrats and

1        Republicans, especially in Maryland when it was a  
2        good person and they wanted to do right by the  
3        people. I had no problem doing that.

4                I put the people first. It's either side,  
5        especially in Maryland. And Maryland -- although  
6        I'm running as a Republican, Maryland has a good  
7        head on its shoulders. They will put things aside.  
8        They're like it doesn't matter. He's right. And we  
9        need that, and they'll vote. They've done it  
10       before.

11               So I'm running (indiscernible). I'm coming  
12        out of the shadows. I'm going to run. I am  
13        running. The campaign website -- the official site  
14        will be up very shortly and here we go.

15               The official kickoff is of course in  
16        November, but we are already started. I have some  
17        very solid people around me, wonderful people, some  
18        whom I have met on Twitter and they're helping.  
19        They're doing everything they can.

20               But we are very much a grassroots operation  
21        and can use all the help we can get, any support. I  
22        hope we have the support of the medical and the  
23        hospital and research institutions (indiscernible)  
24        Maryland because I have a history with them, but I

1 need the people. The hospitals don't vote.

2 You know, financial support, great, but I  
3 need votes. I'm not one of those politicians, you  
4 know, and I'm not here to win a race. I'm not here  
5 to say, "I won. Give me stuff." I'm here to be  
6 hired to do a job.

7 And it's going to be a difficult job. It's  
8 going to have to take the country first, and you're  
9 going to need some type of medical background, some  
10 type of knowledge when this is already going on.  
11 You can't have somebody say oh, there's a problem  
12 and, um, give me a few weeks to get back to you  
13 because I have to talk to six professionals way over  
14 there.

15 We don't need that. I'm qualified to do  
16 the job, and I have a background that allows me to  
17 do it fast and effective. I've always been the one  
18 when there's a problem, I'm going that way. I'm go  
19 to stand right in the middle of a riot and see what  
20 I can do.

21 STEW PETERS: When the site goes live, when  
22 it becomes official in November, when you -- using  
23 your words -- come out from the shadows, will you  
24 come back here and can we do this again?

1                   JONATHAN McGREEVEY: I'd be happy to. I'm  
2 very grateful for the time and time with the  
3 audience. I know everyone is busy trying to survive  
4 and get through this.

5                   STEW PETERS: Yes.

6                   JONATHAN McGREEVEY: Everything is still  
7 very much manipulated, so I appreciate everyone's  
8 time a great deal.

9                   STEW PETERS: And we appreciate and value  
10 these listeners as well and the people that take the  
11 time to view it.

12                  By the way, I wanted to make sure that you  
13 are aware that this discussion in its entirety will  
14 be put up at StewPeters.TV, but we will also take  
15 the opportunity to segment this and try to break it  
16 down into topics so that you can, you know, replay  
17 it 10, 12, 13 minutes at a time at your leisure, and  
18 we appreciate this person being here today.

19                  Jonathan McGreevey, Doctor,  
20 @Johnheretohelp, I cannot tell you how humbled I am  
21 by you coming on the program. I have oftentimes  
22 said I am no hero but I have walked alongside of a  
23 few, and I believe that you are one of them. I  
24 believe you to be a credible person. I believe you

1 to be telling the truth.

2 You have corroborated everything that was  
3 released by Lin Wood in those transcripts as being  
4 true and accurate. You've said that you can  
5 corroborate it with fact. You have called on Major  
6 General Walker and the current Sergeant at Arms to  
7 come forward. You have called for a veil of  
8 protection around him.

9 Senator Cruz, Senator Paul, please do the  
10 right thing. It is time for us to stand up for this  
11 country.

12 Any final words from you, Dr. McGreevey?

13 JONATHAN McGREEVEY: Thank you very much.

14 I am credible, certainly. A hero? Not at all. I  
15 do what needs to be done, so that's all you can do.  
16 I said I'll put everyone first. I've always done  
17 that, even to my own detriment, and I will continue  
18 to do so if you see fit to hire me, and I appreciate  
19 it.

20 STEW PETERS: Thank you for your bravery.

21 JONATHAN McGREEVEY: Thank you very much.

22 STEW PETERS: Thank you very much for your  
23 bravery and for your humility. We appreciate it.

24 Dr. Jonathan McGreevey, thank you so much for being

1 here. We really appreciate that.

2 A credible whistleblower. I believe him to  
3 be telling the truth. Again, it's not my job to  
4 determine whether or not somebody is telling the  
5 truth but rather just to establish their  
6 credibility, and I think that Dr. Jonathan McGreevey  
7 has done that.
